- 5) Not later than 20 days after any change occurs in the information comprising the application, the Director shall be advised of any such change.

This Certificate of Registration may be suspended or revoked by the Director in the event of failure to comply with the above-mentioned conditions or with any applicable regulations.

This Certificate of Registration shall expire on the date shown below unless revoked earlier. An application for renewal of this Certificate should be submitted at least three months before the expiry date.
